# Welcome to Torquay United

In welcoming the Plainmoor Club to the County Ground this evening, we extend a warm welcome for the second time this season. On the first occasion, to our cost, we allowed United to turn a first half deficit, due to a twenty-fifth minute penalty from Alan Mayes, into a 3-1 victory. On that September afternoon, an own goal by Scott Endersby, plus further goals from Colin Barnes and Dean Mooney, allowed Manager David Webb's team to return home to the glorious Devon county with their first away win of the season.

Beset by injury problems, which has necessitated in the Club having to utilise twenty seven players in matches this season, has only compounded the problems facing Manager David Webb in his efforts to bring better days to one of England's most attractive South Coast resorts.

finishing all first leg With the square, when a first half shot from took a wicked Derek Hall deflection past Scott Endersby, eventually being neutralised by Lou Macari's eighty goal which first minute equaliser. A memorable personal brought him to a milestone of one hundred goals in English football. We come to the County Ground this evening with all to play for.

League results count for less where Cup competitions are concerned. So a look at United's Cup form this season may be more appropriate. In the first round of this seasons Milk Cup they were beaten by South Devon neighbours Plymouth Argyle. Single goal victories in both legs were enough to enable the Home Park Club to emphasise In this their Third Division status. seasons F.A. Cup, two second half goals in the space of two minutes from Ben Laryea, now departed from the Club and player coach Eddie Kelly, were enough to send famed F.A. Cup giant killers Yeovil Town back to Somerset with a 2-0 defeat from their first round visit. Alas, three second half goals in the next round saw the Plainmoor Club make their exit at Brisbane Road, home of East London Club, Orient.

The following players were included in Manager David Webb's squad for the first leg match:-

Goalkeeper KEN ALLEN has missed only two League matches this season. The 33 year old keeper joined manager David Webb for the second time, when he joined United last season. They were previously together at Bournemouth, which was Ken's first Club after moving to Dean Court from Bath City. He went onto make 152 League appearances in five seasons for the Cherries. Brief spells with Bury and Peterborough United, brought no League appearances and until the enforced break due to bad weather, Ken had brought his total of League appearances to 185 in last month's home match with Crewe.

The injury crisis encoutered by United was a blessing in disguise for GARY WRIGHT for it enabled the non contract player to make his League debut in the New Years day fixture at home to Aldershot. Unhappily for Gary it ended in a 3-1 defeat, but he retained his place for the following match at home to Crewe wearing the No.2 shirt.

Full back COLIN ANDERSON is one of three players to be ever present this season. The former Burnley apprentice is now in his third season with the Club. Twenty two year old Colin made his one hundredth League appearance for United in the home match with Blackpool on December 15th. Colin's only goal of the season came three minutes from time in the following home match with Southend United.

defensive the central Occupying positions in the first leg at Plainmoor were DEREK FOWLER and STEVE PUGH. Local born Derek made his League debut at Hartlepool on March 17th 1984. Twenty three year old Derek struggled to make United's team in the early part of the season, but including the home match with Crewe he had brought his total of League appearances to twenty five. Derek's only goal of this season came in the 1-1 draw with Darlington in September at Plainmoor. Steve who reached his twentieth birthday was former Wolves last Friday a apprentice. He joined Torquay last season and went onto make thirty eight League appearances by the end. His appearances have been more limited this season though.

Former Leicester City, Mansfield Town and Bournemouth player DEREK DAWKINS has match this appeared in every league The former Leicester season. made his 100th League apprentice, appearance in United's final League match of last season at home to Blackpool. Another player to have joined David Webb for the second time. Twenty five year old Derek is still waiting to score his first Leaque goal.

Player Coach EDDIE KELLY is a veteran of 371 League matches and six League Clubs. Glasgow born Eddie will be 34 on Thursday. The former Scotland Under 23 International began his career with Arsenal, after 175 League matches with the Highbury Club he moved onto the following Clubs with League appearances alongside, Q.P.R. 28, Leicester City 119, Notts County 27, and Bournemouth 13, Eddie won an F.A. Cup Winners Medal in 1971 when he came on a substitute for Peter Storey scoring the second goal in a 2-1 win over Liverpool at Wembley.

On loan from Bristol City in his second month with United is GARY MARSHALL. His move to Plainmoor enabled Gary to make his League debut on December 22nd versus Southend, scoring his first League goal four days later in the Boxing Day derby at

Exeter direct from a corner kick.

The third of United's ever present players is former Coventry City apprentice DEREK HALL. The 20 year old midfield player made his League debut for Coventry City on September 18th 1982 at St. Andrews in a 1-0 defeat versus Birmingham. This was his solitary appearance for the Highfield Road Club. After a period on loan to Torquay in which he played in the final ten League matches of last season. he joined the Club on a free transfer last summer. Scored the only goal of the match on his debut for United at home to Mansfield on March 24th 1984. Derek's three goals this season have come in away matches at Bury on December 1st and the Boxing Day derby match at Exeter City also at Port Vale on January 26th.

When 18 year old MARIO WALSH made his

debut in our first leg match at Plainmoor he became the 27th player to don a United shirt this season. Mario is on loan from Second Division Portsmouth.

Veteran striker JOHN SIMS is in his second spell with the Club. For after releasing him last season for financial reasons, Torquay re-signed him from Exeter City in November. His goal tally for the season upto our first leg match was seven two for United, and another five for Exeter City. Following the home match with Crewe 32 year old John was only six appearances short of 350 in Football League appearances while he needed a further fifteen League goals to reach a century. Despite having appeared for eight Clubs namely Derby, Luton, Oxford, United, Colchester, Notts County, Exeter City, Plymouth Argyle and Torquay United. John has shown a distinct liking for Devon, by playing the majority of his League matches for the three South West Clubs, a total of 256. John holds the unusual distinction of scoring for and against his two League Clubs this season. For Exeter in a 5-0 win over United on the opening day of the season, and for United in their 4-3 defeat at Exeter on Boxing Day.

Local boy ANDY BEST made his League debut this season at Scunthorpe United on October 23rd in a 2-0 defeat. Andy's only two goals to date came in a 3-1 defeat at Northampton on December 29th and in the 2-2 draw at Port Vale on January 26th.

Seventeen year old non contract striker MARK LORAM was one of the substitutes in the first leg. Still waiting for a first team appearance Mark come from South Devon Club Brixham Villa.



## Focus on the Freight Rover Trophy

The former Associate Members Cup now in it's new guise was introduced during the latter half of last season for Third and Fourth Division Clubs. The tournament was organised on a regional basis with the winners of the the Northern and Southern Finals meeting to decide the ultimate winners of the trophy.

There were no replays, where scores were level after extra time, ties were

decided on penalties.

The first round was played on a straight knockout basis, but there was an early incentive to play attacking football, for the two losing Clubs in the second round of both regional competitions who had scored the highest number of goals in the first two rounds also earned a

place in the Quarter Finals.

On our visit to Wrexham last month their club programme referred to the competition as the 'Mickey Mouse Cup' in comparison to the F.A. Cup. There should be no comparison, for the F.A. Cup is open to non-League and the First and Second Division Clubs. While the Freight Rovers Trophy is for Third and Fourth Division Clubs alone. Unfortunately it is a widely held view among the media and some within the game itself.

While no conclusive evidence can be put forward in defence for it's existance, all competitions must prove their worth, surely it deserves a chance? Otherwise you

would not be here this evening.

for this Improvements competition include sponsorship and an appearance for Finalists the two Wembley. That alone should be enough the players. For the incentive for majority will have no other opportunity of appearing at the illustrious venue. After witnessing an F.A. Vase Final Forest Green distant between seasons Rovers and Rainham Miners Welfare and seeing the joy and pleasure gained by Players and Spectators alike, it is no less a satisfactory emotion than that such followers of by experienced and . Liverpool clubs as illustrious Manchester United or Swindon 1969.

There are thousands of fans who will never see their Clubs win at Wembley. This is an extra opportunity, not to be easily dismissed. You will see no miserable faces outside Wembley in June! Not beforehand anyway.

Cynics will quickly ask who won the

competition last season? The retort must always be - who won the first F.A. Cup Final? - And the first Football League Cup Final? In most cases they will not know, why should they, it is history and almost irrelevant to today's modern soccer. The important point is that it was never intended to compete with the two senior Cup competitions, but purely a Cup competition for the lower Divisions. Revenue and a Wembley Final will be well to the fore in most Clubs minds, and I would be very grateful to watch my Club at Wembley again - and so would you.

As already stated the competition will survive or fail on its own merit, if

crowds support, it will thrive.

Last seasons competition attracted 133,399 people through the turnstiles. A breakdown of those figures show that twenty-four first round ties attracted 53,970, giving an average attendance of 2,248.

Eleven second round ties were watched 26,117, a slight increase in the average attendance to 2,379. The Quarter Finals were still on a regional basis, and the average increase in further attendance to 2,757 from the 22,063 who witnessed the eight matches. Attendances for the four Northern ties were higher with 12,847 giving an average attendance of 3,211. In comparison to the average of 2,304 from the aggregate attendance of 9,216 in the South.

Average attendances still continued to rise, as they usually do in all Cup competitions as they progress. For 15,109 watched the Semi-Finals for an average of 3,777. There were Northern and Southern Semi-Finals, with two Northern Semi-Finals having a slightly higher average attendance of 3,884 compared to 3,670 in the South.

The Northern and Southern Finals attracted 5,478 to watch Hull City defeat Tranmere Rovers 4-1, and 4,058 saw Bournemouth gain a 2-1 victory at the expense of Millwall at Dean Court.

The Final at Boothferry Park saw Bournemouth become the first winners of the Cup when 6,544 saw them defeat Hull

City in an away victory by 2-1.

In last seasons competition we were drawn away to Oxford United where after a goalless first half, two goals from Jimmy Quinn and one from Alan Mayes gave us a 3-0 lead, before an own goal from Colin



Bailie gave the Manor Road Club their only consolation in a 3-1 defeat in front of a crowd of 4,744.

In the second round we met another of last seasons Third Division successful Clubs Walsall. First half goals from Simon Gibson and Alan Mayes sent the Saddlers in at half time with a 2-0 deficit, a further goal from an Alan Mayes penalty sent the Midlands Club home with a 3-0 defeat, watched by 2,705.

We went out of the competition in the Southern section Quarter Final to Millwall by 3-1 in front of 2,112. We trailed 1-0 at half time to a Gary Emmanuel own goal and didn't help ourselves by conceding a second half penalty to Steve Lovell, and a further goal to Kevin Bremner, our consolation was scored by Gary Nelson.

An aggregate of 9,561 attended our three ties, averaging 3,187. Welcomed finance, an opportunity for players to meet higher opposition, a local derby and the only interest in a disappointing second half of last season.

The first hat trick of the competition was scored by Steve Elliott of Preston North End, when he scored all the goals of the Deepdale Club's 3-0 away win at Rochdale. Steve is now with Walsall after a brief spell with First Division Luton

Yown, you may recall that Steve was transferred in part exchange in a £150,000 deal that took David Preece the talented Saddlers midfield player to Kenilworth Road.

Stewart Mell the goalscoring hero of Burton Albion, one of this seasons F.A. Cup non-League success Clubs, was the first substitute used in the Associate Members Cup when he came on in the second half of Halifax Town's 2-0 defeat at Tranmere.

The first goal recorded was scored by Glen Pennyfather of Southend United in the Essex Club's 5-0 home win over Reading.

A curious fact of last seasons competition was that Bournemouth defeated Millwall twice, in the second round on penalties after a 2-2 draw at the Den, and 2-1 in the Southern section Final. That we met Millwall came about because of their goalscoring exploits in qualifying for one of the high scoring positions allotted for the two highest scoring losers of the first two rounds.

This evening's match will decide whether we can enter the second round of the newly named Freight Rover Trophy. They above all will be hoping the second year of this newly innovated competition will be a success.



## The Value of Pre-Season Matches

A recent statement by a First Division player refuting the value of pre-season friendly matches was in stark contrast to the belief held by Andy Rowland in his early season article in the local newspaper. It does not take a lot of consideration to agree with Andy's view, but are they given enough thought in planning by Managers?

Many factors govern the arranging of pre-season matches, the state of close season work on pitches, which Division the opposition play in, for instance. First Division Clubs rarely visit each other, preferring to visit the Continent, Ireland

or Scotland.

Clubs in the lower echelons of the League regularly Football attractive First Divsion Clubs. Some pay visits of goodwill to Clubs in the local vicinity which also acts as a good public relation exercise. All have their merits, except when you meet over zelous opponents who tend to want to prove a point against the recongnised player. We can recall to situation which the injury our cost occured before the commencement of last season, when we had to cancel several of our pre-season matches.

So what is the ideal build up to the first kick off? A careful study of Clubs in recent seasons who have had successful teams tend to show that if falls into two categories. First, newly promoted Clubs often do well in a higher Division often due to the form and spirit engendered from the previous season, current examples are Oxford United and on a more moderate comparison the early from of Bristol City and York City two of the Clubs from last seasons Fourth Division. Not so in the First Division where finance and crowd support are more inclined to dictate the

The former category is also dictated by finance although on a much smaller scale, where Clubs, if they can afford the expense, allow the manager to take his players on a regional tour, or play in Scotland. Mostly against slightly inferior opposition, whereby confidence in obtaining satisfactory results allied to cohesion, also benefits the players who experience a growing team spirit within the company of their close knit environment.

It is traditional in English soccer to have the playing staff report

approximately a month prior to the seasons commencement, but there are a few managers now breaking with tradition, especially when as often happens in the lower Divisions, a number of close season signings have been made.

For those players to gel into a cohesive team framework they now ask them to report six and even seven weeks before the late August kick off, this obviously enables the manager to have longer to put

their ideas into practice.

One of this seasons successful Clubs outside the First Division adopted this totally playing two procedure, matches against insignificant practice what could be politely called village green oposition. A 10-1 and 8-1 victory was no more than expected, but it did the players no harm. They were taken on a ten day tour of an English region playing.two non-League Clubs and two League Clubs of a lower Division. They did not win every match, but they also did not lose. After returning to base they played two more matches against minor Clubs and have not looked back since.

The previous pre-season they toured Scotland with similar results against Scottish 1st and 2nd Division clubs and had a successful season. Does this prove that to break with tradition is right? Of course it does not because it is easy to quote an opposite succes, but it does empthasise an old adage, 'that a change is as good as a rest'. When next pre-season comes it will be interesting to note what various Clubs adopt in their build up to a new season.

Finance in our stringent need for economy dictates events. But once again change is occuring in this climate, for sponsorship now enables some Clubs to break with tradition and a watching brief on subsequent events may be a pointer to a

change in method in future.

On a lighter note it is often amusing to read newspaper reports of pre-season matches from within the vicinity of Non-League Clubs. When a former European Cup winning team were due to visit a local Non-League Club, National daily the almost daily were running newspapers reports of the Clubs activities in Spain, meanwhile the local newspaper was busy quoting statements from the oppostion's various Internationals and headlines that a full strength team would definitely

## ELASHBACK

10 YEARS AGO - February 1975

Saturday the 1st was to have been a home game with Brighton, but the state of the pitch following the previous weeks Cup-tie forced its postponement for three days, when a David Moss penalty six minutes from time gave the Town a 1-0 victory in front of 9,561. The following Saturday the Town made the trip to Cleethorpes to incure a 2-0 defeat at the hands of Grimsby, before the short journey to Aldershot on the 12th. 4,538 saw Peter Eastoe score after 35 minutes to give Swindon both points.

Three days later and Preston were the visitors, marking another landmark in the career of John Trollope - his 600th League appearance. Eastoe got the first-half goal that gave the Town victory and a fourth placed spot, 11,892 looking on. For the return at Deepdale the following Tuesday Swindon were without Moss, who was starting a three match ban, only adding to what was becoming an injury hit side. Indeed Moss's stand in, Tommy Jenkins, managed to collect a groin strain as the Town went down by two goals to nil, and was unavailable for Saturdays match at Gillingham. Mick McGovern fitted into a rearranged team, but despite an eighth minute penalty by Trollope, Swindon lost 3-1 and slid to 6th place in the process. In fact McGovern had turned down a move to Chelmsford earlier in the month, and a proposed move to Aldershot was put on ice at the end of the month, as the injured list now totalled six.

20 YEARS AGO - February 1965

Swindon were still struggling to put a run of good results together, a cause not helped by having to travel for three of the four fixtures this month. A trip to Huddersfield on Saturday the 6th resulted in a 2-1 defeat - after having gone two down by half-time Swindon put on a better display in the second-half but failed to score until six minutes from time, when Dennis Brown converted, but by then it was too late. A similar story was to be had one week later when Derby County played hosts - a Mike Summerbee goal in the 75th minute again coming too late to affect the result as Derby knocked in four, two in each half.

Having now slipped to 19th place a win in the home game against mid-table

Coventry on the 20th was becoming a necessity, and a win it was. Don Rogers scored after 8 minutes to start the proceeding, and got his second just before half-time, interupted by Summerbee's 39th minute goal. Although Coventry pulled one back in the second-half, Swindon added their fourth through Owen Dawson after 52 minutes to seal a moral boosting win. However a trip to Cardiff seven days later highlighted many of the problems Swindon had to overcome. Despite holding Cardiff until the second-half, Swindon failed to capitalise on their pressure, and instead of coming off worthy winners eventually went down by 2-0, both goals coming from corners.


30 YEARS AGO - February 1955

Promotion contenders Gillingham were the visitors on Saturday the 5th, but Swindon produced a minor upset as Roy Sampson scored twice within two minutes, one from a penalty, to secure a 2-1 win and send most of the 6,477 home happy. But despite the win only 4,715 turned out the following Saturday to see the goal-less encounter with Crystal Palace. Inbetween these two games the reserves 4-2 defeat at Brentford was the first competative game to be played under floodlights at Griffin Park. Wednesday the 16th saw the return friendly against Headington United at the County Ground. Maurice Owen, making his come-back after a leg injury, scored the only goal of the game in the 56 minute, watched by 1,786.

The following Saturdays game at Northampton having already been played in December, Swindon made use of the blank date by playing the Wiltshire Professional Shield reply at Chippenham Town. The Western Leagures managed to hold the Town to a goal-less draw, but goals from David Gibson and Owen in Extra-time secured Swindon's place in the final. The game on the 26th, one week later, at Shewsbury was called off, Swindon ending the month with a free day.

## Junior Robins Page

As there is a tendency for a smaller number of Junior Robins to attend evening matches compared with those played on Saturday afternoons, I thought I would use the column this evening to give a few answers to questions relating to the laws of the game. I hope this will be of general interest to programme readers as well as helping Junior Robins to improve their knowledge of the game.

Q. Why does the referee sometimes stand

with his hand in the air?

A. This is to signify that a free kick is indirect. The referee should keep his hand in the air until the ball has been played by another player. Players asking referees if a free kick is direct do not know the rules of the game.

Q. Can a player be sent off for using foul or abusive language if it is not directed

at the referee?

A. Yes. Law Twelve states that a player shall be sent from the field if in the opinion of the referee he uses foul or not matter abusive language. It does whether it is to the ref, an opponent, a team mate or a spectator. Indeed there was an interesting case recently where a club was player registered with one watching a match between two other teams. He was reported by the referee and punished in exactly the same way as he would have been if he had been playing. So, at the risk of plugging a TV programme it pays to "Mind you language".

Q. What is the point of the six yard box?
A. It indicates the area within which goal kicks may be taken. It is also of importance in relation to the charging of goalkeepers. Charging the goalkeeper is not allowed except when he - a) is holding the ball; b) is obstructing an opponent; c) has passed outside his goal area.

Q. If a ball rebounds off the cross bar and lands three quarters over the goal line is it a goal?

A. No. The Laws of the game state that the whole of the ball must cross the goal line either on the ground or in the air before a goal is scored.

Q. When can you not score from a direct

free kick?

A. When it's an own goal. If a player taking a free kick outside his own penalty area accidentally kicked the ball past his own keeper into the goal it would not count even if it was a direct free kick. If a player plays the ball into his own net it is a corner whether the free kick was direct or indirect.

Finally, I would like to urge all supporters to join the Supporters Co-operative. Not only does membership (£1 for adults, 50p if you are Under 16) entitle you to discount from a wide range of shops in the Swindon area, you will be helping make the County Ground a safer

place for youngsters to come to.

Video cameras were paid for by the Coopertive for filming the crowd at last
season's match with Bristol City. As a
result there was no trouble inside the
ground. The effectiveness of systems like
this has encouraged the League to consider
placing such equipment in all First and
Second Division grounds so it is good to
think that Swindon have once again been
pioneers in something which can only be
for the good of football.

# BEHIND THE SCENES



#### BY BOB JEFFERIES

The Freight Rover Trophy is the first Football League's competition for the Third and Fourth Division Clubs which will end with the glory of a Wembley Final. The date if we get there is 1st June 1985. That in itself is sufficient to make the Freight Rover Trophy, which replaces last season's Associate Members Cup, a unique event. But there is more to it than that Freight Rover's sponsorship is worth about £50,000. The first £30,000 will go to the prize-fund for the more successful clubs and the two Wembley finalists will each receive a Freight Rover 15 seater minibus worth about £10,000. The Sherpas, buses are called, will be presented to the Clubs painted in their colours. As the Sales and Marketing Director of Freight sponsorship was when the Rover said first round, announced "Even in the supporters and players will realise that the Wembley dream is only a handful of matches away - it could be their turn for the big day out".

There is one other major difference between the Freight Rover Trophy and last season's Associate Members' Cup in which A.F.C. Bournemouth beat Hull City 2-1 in the Final and that is that the first round has been made two-legged to give all fans a chance of seeing their team at home in the competition. From then on it is a

straight knock-out.

The competition is divided geographically into North and South areas, the final, therefore, will be contested by the winners of the two Area Finals.

The second round will comprise twenty four clubs, the third round will consist of the twelve winners and the two highest

scoring beaten clubs in each area. This creates an added incentive to go all-out for goals in the first two rounds. For example, a club scoring say eight goals in winning the two-legged first round tie and then losing 4-3 in the second round must have every chance, with eleven goals, of making one of the two places available for the top-scoring clubs.

Two other relevant rules are:-

In all matches if the score is level at the end of ninety minutes an extra half hour shall be played except in the first leg of the first round when only ninety minutes will be played. If the score is still level at the end of extra time the winner shall be determined by the taking kicks from the penalty mark in accordance with the Laws of the Game.

Up to a maximum of the two substitutes

may used in each match.

The remaining rounds will take place in the following weeks commencing:

Second Round 18th February Area Quarter-Finals 18th March Area Semi Finals 1st April Area Finals 13th May National Final 1st June




