

This is their second visit to the County Ground this season due to the fact that this fixture was postponed on the original date with forty five minutes left to the Kick off. Since that March day the Feethams club have made a change in their management with the dismissal of Cyril Knowles who has been replaced by

There appear to be several changes in prospect for next season as far as the Football League are concerned. The management committee have taken the decision to introduce Red and Yellow cards again! This is in response to what they regard as the wishes of the spectators and media.

The cards - red for a sending off and yellow for a booking - were scrapped in 1981 because of an escalation in the number of cautions. At that time it was felt that referees were reaching for their cards too quickly. Once they had committed themselves to showing them it was considered that they were forced to administer the caution. It would appear that since the cards were scrapped the cautions have not diminished. Of course most other countries have adopted the scheme of showing cards. To reduce the fear of card-happy referees, they will have to take the number of a player before showing the card. It is envisaged that everyone will see straight away when a player has been sent off.

It has also been decided that the end of season play-offs to decide the relegation and promotion issues will climax on May 22nd and 25th, with replays if necessary on May 29th.

The play-offs were introduced for the first time this season as part of the League's bid to reduce the First Division and to provide more interest to end-of-season fixtures. The play off details for your interest are as follows.



Seini Finals: First leg to be played Thursday May 14th or Friday 15th (to be decided by the League). Second leg, Sunday May 17th.

If the aggregate scores are level after both legs extra time will be played. If the teams are still level away goals will count double. There will be a penalty shoot-out if necessary.

The finals will be played over two legs on Friday May 22nd and Bank Holiday Monday May 25th. The home team in the first leg will be decided by the toss of a coin. If aggregate scores are level the tie will go to a third match to be played on Friday, May 29th.

The League have yet to decide whether replays will be held at a neutral venue or decided by the toss of a coin.

Did you know that just when football seems to be attracting higher attendances it is likely to be threatened again in ten years time? How will the Football Association react when in the mid 1990's European club matches are being shown live on Cable TV in England?

A fresh problem for Engand but one the continentals have lived with for many years. So far this season 21 Cup and League games have been screened by B.B.C. and I.T.V.

As far as this country is concerned, live soccer has been an unqualified success. It has stimulated interest in a much maligned sport and attracted viewing figures which appear to claim it is a runaway success.

Apparently 73 million have watched live matches on B.B.C. while 1.T.V. have claimed 43 million viewers for two less matches.

Meanwhile the beaming of live matches to the Continent has upset Belgium who claim the unwanted import is mainly responsible for 10% decline in their Sunday afternoon gates and accordingly they have complained bitterly to the Football Association. It is easy to understand their point of view for B.B.C. programmes go out officially on their cable networks which means their domestic games are in direct competition with a live match in England.

Apparently there is tacit agreement or as they claim approval from the E.E.C. whose view is that if one country's programmes can be received in another, then they have the right to

From a distance it would appear that Governments have made a hopeless ass of TV arrangements within the E.E.C. Obviously there is little copyright protection.

This situation will certainly set alarm bells ringing through English football eventually, yet can we really complain for England is the only country in Europe giving regular live games on TV! A worrying aspect is that we are among the most cabled countries in the world!


Footballs agreement with the Television com-


The majority of fans that travelled to Bristol recently to see our 4-3 win against Bristol Rovers would have left Ashton Gate well pleased with the final outcome. I was just relieved that we had collected three pointes after trailing by two goals.

As I have said before it is important that we collect all three points irrespective of how we play. Having said that I did not intend for my players to commit hari-kari, gift the opposition goals and then try to obtain a result. That is sheer lunacy, I did not leave Ashton Gate a happy man, just a feeling of sheer relief. I make no hasty judgement in stating that we gave one of the worst defensive performances that I have seen in my career. Tackling is part of the game and yet there we were playing with a "after you Claud" outlook.

We gave Bristol Rovers goals they did not deserve, although I will admit they played with a spirit that should see them escape relegation.

I do not excuse any of my defenders and they must take a collective responsibility. I left my feelings about the situation is no doubt the following day when we analysed the match. Any more wretched displays in defence like that one and we can forget any ides we have of promotion. Can you imagine what would have happened if we had been playing against better opposition, it was as well we were meeting Rovers at Ashton Gate and not City. It is sometimes beyond a manager why his players will suddenly attempt suicidal motions that they do not normally attempt, is it lack of concentration indeciseness or just poor play?

We have reached second place in the Third Division by being professional and now is the time for the players to capitalise on their seasons approach. It is not always possible to be on top form but it is a time to ensure that the basic fundamentals are applied. Sloppiness as no time in my approach to the game and the defence that played at Ashton Gate played sloppily. All five were indecisive and ill disciplined it is something I do not wish to see again this season. If it had not been for the form of the players in attack we would have returned from Bristol empty handed. Our midfield could not be absolved from blame, they are our first line of



defence as well of attack, they did not defend by putting tackles into an area of the field where too many attacks built up.

We have now reached a stage where every single point is vital and the team that displays the highest degree of prefessionalism will gain promotion. My players can show that as they have confirmed before this season. A quick return will ensure we stand as good a chance as the rest of the promotion contenders. We were lucky to get away with three points in an ill disciplined display.

For the rest of the season can I appeal strongly to you all to cheer the lads like you have never done before. The Second Division beckons and we shall have to try to ensure there are no slipsups to the end.

We have Charlie Henry now back in our squad after his months loan with Fourth Division leaders Northampton Town, his return provides other options for me in midfield, or defence. I don't want anyone to feel that because we are playing lowly Darlington this evening that we have any easier passage then if we were meeting Bournemouth or Middlesbrough. Teams in the lower half as Bristol Rovers demonstrated can be dangerous any underestimation and a seasons work can disappear. The same attitude will apply when we visit Carlisle United in eleven days time that will be another test of our resolve for they recently gained a 1-0 win at Port Vale. It just shows teams at the bottom scrap as hard as those at the top.

Malcolm Beard, former Villa and Blues wing-half is all set to become chief scout of the Third Division club, where he will be joining two other old Villa favourites. Bruce Rioch is manager of the Teesside club, while Brian Little is now Boros' Youth team coach.

Bristol City may have to play four promotion play-off games and a Wembley final into the last fortnight of their busiest ever

Terry Coopers team are almost certain to complete at least 62 League and cup fixtures - and might face as many as 67. That will not be many more matches than Lou Macari's men for without being involved in the play-offs we will have completed 59 matches by the end of the season, 46 League fixtures, 4 Littlewoods Challenge Cup matches, 4 F.A. Cup fixtures, and 5 in the Freight Rover Trophy!

Roger Freestone had made just thirteen league appearances before Chelsea snapped him up in a £160,000 deal! Roger is currently back with Newport County on loan until the end of the season. A case of lucky thirteen for some!

Harry Redknapp the A.F.C. Bournemouth manager admits his extensive knowledge of the non-league scene has helped him to build a promotion team in this seasons Third Division. He certainly has a point for his table topping outfit has been built with free transfers and cheap signings from non-league football or the lower divisions. I spend an awful lot of time watching non-league football. It's a fertile area for bargains'. Their success this season has been all the more remarkable when you consider the Dean Court club were forced to part with one of their biggest assets! For last season Colin Clarke netted 35 goals for the South Coast club before selling him to Southampton for £400,000. They replaced him with David Puckett from Southampton and he had scored 16 goals in 17 appearances before sustaining a serious knee ligament injury against Bristol Rovers on Boxing Day. Unfortunately he will be out of action until the beginning of next season.

Walsall Chairman and City tycoon Terry Ramsden a most fearless gambler and owner of a string of horses plans to become a big-time boxing promoter and share the limelight with the likes of Mickey Duff and Frank Warren. His application for a licence comes before the "British Board of Boxing Control" on May 8th. Terry Ramsden wants to serve a quick promoters apprenticeship before graduating to lucrative television shows. Fulham were finally saved from extinction thanks to their former player and new TV commentator Jimmy Hill. He led a consortium that bought out the Fulham name and players' contracts from current chairman David Bulstrode. Agreement was also reached for Fulham to play at Craven

Cottage next season. David Bulstrode whose bid to develop the ground caused a major row is now planning a partial redevelopment of the site.

Fulham will play at Craven Cottage under licence from Bulstrode's Marker Estates Company and will stay until building begins in two or three years.

The new moves will mean that Jimmy Hill will become chairman of Fulham F,C, 1987 and will step down as a director of First Division Charlton Athletic. So the abortive bid to merge Fulham with Queens Park Rangers is now at an end. Football and Fulham in particular will breathe a heavy sigh of relief.

Did you know that our striker Steve White scored his first League goal in an away fixture that never took place on the ground of the opponents? For Steve scored his first goal for Bristol Rovers on April 1st 1978 against Millwall at Portsmouths Fratton Park in a 3-1 win before a crowd of 3,322. Steve had actually made his League debut the previous Monday at Southampton in a 3-1 defeat. Appearing in the Rovers line-up alongside Steve was Bobby Gould who was eventually to become Rovers manager when Steve was released to move to the County Ground last summer.

Steve's recent hat-/trick against Mansfield Town here at the County Ground was not his first in League matches. For the record below are Steve's moments to

In front of a crowd of 1834, the smallest league attendance to watch them this season, Swindon gained a point in a 0-0 draw at Feethams on 25th October last year.

The match in the North East is one of many this season that can be looked back on by the "Town" as an opportunity for maximum points wasted. Had a 44th minute goal by Steve White for the visitors been allowed there can be little doubt that they would have gone on to win. Lurking in the six yard box, White provided the final touch to a Dave Bamber header, forcing the ball over the Darlington line, the contingent of "Town" fans at the game had the same view of the incident as referee Malcolm Scott but their opinion differed greatly to the official, who penalised White for handball. The denial of a vital breakthrough a minute before half time seemed to be the first indication that this was not to be Swindon's afternoon. An early injury to Dave Bamber which caused him to struggle for most of the game, did little to help the "Town" develop any punch up front. Only the 58th minute introduction of Alan McLoughlin seemed likely to bring the crucial goal, but even then Swindon did not get the luck that would have decided the game. Chris Ramsey was just unable to meet a David Hockaday cross properly and put his header over the bar and six minutes later Dave Bamber was thwarted with only the keeper to beat. Darlington's best effort of the game came in the 71st minute, when Alan Roberts forced a superb save from Fraser Digby with a swerving free kick. A goalmouth melee ten minutes later nearly brought the winner for Swindon, but once again their final effort let them down. Alan McLoughlin had a shot cleared off the line which was followed up by Leigh Barnard whose chip found Dave Bamber who volleyed against the post to once again let the home side off the hook. A difficult and icy wind that afternoon made attractive football difficult for both sides and also seemed to blow away any chance of a Swindon victory at Feethams. In order to keep our promotion hopes alive this afternoon, we must hope that we make our own luck and are able to blow away the memory of Steve White's 44th minute "winner" back in October.

The Darlington club was formed in 1883 and celebrated its centenary four years ago.

They turned professional in 1908 and were original members of the Division

North established in 1921.

Since gaining that league status Darlington have enjoyed promotion just three times in sixty-six years – 1925, 1966 and 1985. Apart from one brief spell of two seasons in the Second Division, the club living within the shadows of the North Eastern giants Newcastle, Sunderland and Middlesbrough have found life very tough at times in the lower divisions.

Three times re-election was successfully sought in Division 3 (N), and more recently five times in the Fourth.

50 points in the 1921-22 season - Darlington's first in the League - gave then runners-up spot behind Stockport.

Four years later they went one better winning their first and only Champion ship. A total of 58 points gave them the title, five more than Nelson and New Brighton and a place in the Second Division.

After finishing 15th in the 1926-27 season relegation from the second followed the following year, and there began a long spell of thirty-one years back in the Northern Division.

In 1958 Darlington became members of the Fourth when the north and south divisions were ceased.

Promotion for a second time came at the end of the 1965-66. Only goal difference denied them the Fourth title. The finished on 59 points the same as Doncaster, and one more than third placed Torquay.

The stay in the Third though lasted just one season. The Quakers together with ironically Doncaster, Workington and Swansea being relegated back to the Fourth.

Cyril Knowles, the former Spurs player appointed in July 1983 guided the Quakers back into the Third, in 1985 - the clubs first taste of real success in eighteen years. For a long time they looked favourites for the title, but eventually finished in third place behind Chesterfield and Blackpool.

Last season Darlington ended up in midtable in the Third, but this season have a tremendous struggle on their hands to avoid the drop again.

A few weeks ago Knowles and coach John Craggs were dismissed and the role of care-taker boss until the end of the season given to player Paul Ward.



Colin Greenall (Gillingham) and Gary Pallister (Middlesbrough) I can't argue with the choice of these two players as central defenders there are probably no two better defenders and yet John Williams

(AFC Bournemouth) and Tony Mowbray (Middlesbrough) must have been close to selection.

Kenny Mower (Walsall) The one recollection of the Walsall defender I have is how he flattened Peter Coyne in the first minute of our match Fellows Park. An aggressive defender, the only left back I can think would rival him in our Divison is Paul Morrell of AFC Bournemouth.

Brian Laws (Middlesbrough). A fully justified choice for he was in fine form in the first half of the season scoring goals freely, many of them from free kicks. The injury he sustained came from taking a penalty kick

Asa Hartford (Bolton Wanderers). I can only think he was nominated because he was a name player. I don't think he has been one of the best midfield players I have seen in the Division.

(Walsall). Bobby Hutchinson Although I know Bob well he really was a surprise choice, he is struggling to stay in the Walsall line-up and I would have thought Sean (AFC Bournemouth) O'Driscoll would have been a better choice than either Asa Hartford or Bobby Hutchinson.

David Kelly (Walsall) He has scored a lot of goals this season and that is always a hard job. Not a choice we could argue about.

Ian McParland (Notts County). He would be in most players team for he has been consistent all season.

Tony Cascarino (Gillingham) I have to be honest and say that I have never seen him play obviously he is a handful. Personally I have always rated Paul Stewart late of Blackpool now with Manchester City one of the best strikers I have faced in the Third Division.

Our manager Lou Macari went on record recently saying he did not think that players were the wisest of people in selecting representative teams and it could be a better choice if left to mangers. I would'nt disagree they see more of the players through scouting trips etc and in the heat of a game it is very difficult for players to watch opponents with a view to team selection.

We are attempting to play Darlington at the second attempt here at the County Ground this season, snow halting the first match. They have picked up some useful points of late and we will have to safeguard against any complacency because of their league position. Twice this season they have visited the West Country on wasted trips for not only was the original fixture postponed here at the County Ground but also their recent match against Bristol Rovers at Twerton Park! Their former manager Cyril Knowles didn't seem to mind the wasted trip for he did not want to stay and play the match the following day when the referee called a halt.

Don't forget we shall need all the support you can muster and hope that you will all be here when we face Doncaster Rovers at the County Ground on Saturday afternoon. We desperately need the maximum points from both matches and with your help we will move closer to the Second Division, still a lot to play for vet, one win or loss will not decide our final destiny but it is all part of a season and one which we hope you

will remember.

And we've got Arthur Horsfield And he's the King of them all.


For a short but happy period between 1969-72 this was a cry that often echoed round the County Ground. Arthur Horsfield was always King Arthur to his fans, Carthorse to his critics. Often he would be called both in the same match depending on whether he had just deftly eluded an opponent and stroked the ball home, or skied the ball over the bar when presented with an open goal.

Like so many other players Arthur came from that hot bed of footballing talent Geordie land. He was born in Newcastle but it was Middlesbrough who first signed him as an apprentice professional. His record of 51 goals in 107 appearances with the Teeside Club picked him out as a player of considerable talent and he was rewarded by international recognition in the England Youth team. In 1968 he was transferred to his home town Club Newcastle United but began to find his appearances limited by the emergence of the brilliant Welsh centre forward Wyn Davies and was happy to move to Swindon to gain a regular place in first team football.

At the start of the extremely successful 1968-69 campaign Town manager, Danny Williams had signed Chris Jones for a then Club record fee of £15,000. While things had gone well for Swindon, Chris had struggled to gain a regular first team place and it had been the hard working Roger Smart, more familiar as a wing half or inside forward (midfield player in modern terms), who had worn the number nine shirt in most matches. Sensing that Swindon would need a natural goalscorer in the higher company of Division Two Danny Williams again splashed out a Club record fee of around £17,000 to recruit Arthur Horsfield.

Horsfield's goal scoring ability soon began to win him a place in the hearts of Swindon fans. After the Town had lost their opening Division Two match at Blackburn, it was an equaliser by Horsfield that earned a point in a two all draw at Cardiff. His home debut against Carlisle United was an even greater success. Swindon were trailing by two goals to nil when twice in the last twenty minutes Horsfield chested the ball down and cracked home right footed shots.

By the end of the season Horsfield had notched eighteen league goals and was the Club's leading scorer for the season.



Two of these goals in particular remain in my memory. Villa Park is a ground steeped in tradition and the achievement of victory there showed that the Swindon team of the early seventies was a force to be reckoned with. The first of the two goals that gave Swindon victory came after fifteen minutes when Horsfield crept up on the blindside of the defence to nod home the most gentle but effective header. Late in the season with hopes of promotion still high Swindon clashed in an evening fixture with fellow promotion challengers Blackpool. With only three minutes gone a shot by Joe Butler rebounded of Peter Noble to "King Arthur" who drove it past the Blackpool keeper. At that moment I am sure many Swindon fans like me thought we were on our way to Division One. Sadly a Blackpool equaliser and the decision of referee Tom Reynolds to disallow a "goal" by Noble meant otherwise.

Hersfield notched two hat tricks in his period with Swindon. The first against the supposed defensive masters, Juventus in an Anglo-Italian Cup match when Horsfield struck three times in the last half an hour to add to Peter Noble's opening headed goal. The second came late in his


Swindon career when his lethal finishing combined with the creative play of Don Rogers tore Oxford's defence to shreds to record a four nil victory at the County Ground.

In each of the last two of his three seasons with Swindon Arthur Horsfield notched a dozen League goals Probably a fraction more pace would have made him an even more successful scorer. Unlike most professionals nowadays he was fond of a cigarette he decided to abandon this habit in an attempt to improve his fitness but found he immediately began to put on weight, so that what he gained on the no smoking swing he lost on the weight roundabout.

At the end of the 1972 season an exchange deal, which brought Ray Treacy to the County Ground, took him to Charlton, where he scored 53 times in 139 appearances before he moved across London to finish his League career with Watford and a total of 164 League goals to his credit. One final thought. Look at all the Clubs Arthur Horsfield played for. Every one except Swindon has gone on to appear in Division One. Wouldn't it be nice to think we might one day stop being the exception!



#### INTERVIEW

#### 'Penalty Ref!'

This week we once again talk to local referee Chris Kirkland on penalty Chris was previously interviewed for the programme and when he dealt with the nine offences for which a penalty can be awarded. What happens when a referee has made his decision to give a penalty?

Chris replied "The penalty-kick must be taken from the penalty mark which is 12 yards from the mid-point of the goal-line and when it is being taken all players with the exception of the player taking the kick and the opposing goalkeeper shall be within the field of play but outside the penalty-area and at least 10

yards from the penalty-mark. The goalkeeper must stand, without moving his feet, on his own goal-line, between the goalposts until the ball is kicked. The player taking the kick must kick the ball forward and hs is not allowed to play the ball again until it is touched by another player. A goal may be scored direct from such a kick and should the ball touch the goalkeeper on the way into the net when a penalty kick is being taken at or after the expiration of the first half or full time the goal still stands. If necessary a referee can extend play in the first half or second half to allow a penalty-kick to be taken.

As spectators will have observed at various matches, it may become necessary for a referee to order the penaltykick to be taken again. What are the possible circumstances that may cause this action by the official?

The most common infringement is by the goalkeeper either not standing on his goal line or moving before the ball has been kicked by the penalty taker. Should the goalkeeper save the kick or the player fail to score the referee will order the kick to be retaken.

The other type of infringement committed by players at the taking of penalty-kicks is encroachment, that is a player entering the penalty area or within 10 yards of the penalty-mark before the ball is in play. If this is done by a member of the attacking team and a goal is scored it must be disallowed and the kick retaken. If a member of the attacking and defending sides commit such an offence then whatever the outcome of the penalty-kick it shall be retaken. Should a member of the defending side encroach and no goal results from the penalty-kick the referee shall order the kick to be re-taken.

In my first article on penalty-kicks I mentioned the decision of F.I.F.A. to discontinue the drawing of lots to determine which of two teams should proceed to a further stage of knock-out competition or receive a trophy and replace it with the taking of kicks from the penalty mark.

As Swindon have been involved in such a practice against Bournemouth in the Freight Rover Trophy I felt spectators may like to know the procedures to be followed:-

- 1. The referee shall choose the goal at which all of the kicks shall be taken.
- The referee (not the players) shall toss the coin and the team whose captain wins the toss shall take the kick. Note captain does NOT Have a choice in the matter compared to winning the toss at the start of the game.

3. (i) Both teams shall take 5 kicks

(ii) The kicks shall be taken alternately (iii)If before both teams have taken 5 kicks one side has scored more goals than the other could then the taking of the kicks shall cease.

(iv)If after both teams have taken 5 kicks both have scored the same number of goals or have not scored any goals, the taking of kicks shall continue until such time as both have taken an equal number of kicks and one has scored a goal more than the other viz Aldershot 11 Fulham 10 after 14 penalty kicks!

4. The team which scores the greatest number of goals shall be declared the

Only the players who are on the field of play at the end of the match shall take part in the taking of the kicks. However should a goalkeeper sustain an injury during the taking of the kicks and is unable to continue, he may be replaced by a substitute provided that the side has not used its quota of substitutes.

Each kick shall be taken by a different player and should no result be obtained when all eleven have taken their kicks the process continues with players taking a second kick.

A goalkeeper may be replaced by a member of his own side.

(a) Other than the player taking a kick from the penalty mark and the two goalkeepers, all players shall remain within the centre circle whilst the

taking of kicks is in progress.

(b) the goalkeeper who is a colleague of the kicker shall be on the field of play behind the penalty area and at least 10 yards from the penalty mark.

I hope that these notes may help to make clear what happens in such a situation when a game is decided by the taking of such kicks.







Much has happened and much has changed since last year, but the one element that got us where we are today is still present in abundance, self belief.


Just as last season, hiccups have




#### STEVE WHITE NEARS A CENTURY OF LEAGUE GOALS .....
